## Elise A. Fialkowski of Klasko Immigration Law Partners, LLP, Led Advanced Employment-Based Immigration Session at 2019 NAFSA Annual Conference

Washington Convention Center in Washington, D.C. The panel addressed an audience at this highly anticipated international education event, which adopted the theme of "Global Leadership, Learning and Change."

In keeping with the conference theme, Elise, David, and Donna discussed several hot topics in employment-based immigration, including: the changes to the H-1B visa lottery, PERM Labor Certification, Buy American Hire American (BAHA) executive order, proposals to limit legal immigration, current wage issues, and more.

Fialkowski and her fellow panelists provided guidelines for applying the recent changes to preparing immigration petitions, and specifically how these changes impact hiring and sponsorship at universities. Elise also discussed creative solutions that her firm has seen some success in utilizing. They also covered how to develop policies and compliance programs that will prepare universities for the increased scrutiny and enforcement actions by the immigration agencies.
