The settlement reopened the regional center EB-5 program as of August 2022. He is a member of AILA's Benefits Litigation Committee.

Daniel Lundy has been repeatedly acknowledged as a <u>Top Litigation Attorney</u> in this annual list by *EB5 Investors Magazine*. Dan has extensive and successful experience in representing hundreds immigrant investors in their EB-5 petitions and applications.
